We, Jennie Maude Pruitt and William Warren KNOW ALL MEN BY THESE PRESENTS, that Pruitt

in consideration of Hine Thousand, Two Hundred and Fifty (\$9,250.00) and no/100---Dollars,

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release Charles T. Joye, and his heirs and assigns, forever:

All that piece, parcel or lot of land with all improvements thereon situate, lying and being in the City of Greenville, State of South Carolina, County of Greenville, on the southern side of Pendleton Street, known as Lot No. 3 of the property of Rupert Scruggs, according to plat made by R. E. Dalton, Engineer, on February 15, 1921, less that parcel of said lot conveyed to the South Carolina Highway Department by the grantors herein by deed dated March 1, 1966, recorded in Deed Book 792, at page 647, RMC Office for Greenville County.

Following is a description of Lot No. 3 by metes and bounds: BEGINNING at an iron pin on the southern side of Pentleton Street, corner of J. B. Scruggs property and running thence along line of J. B. Scruggs property, S. 20-30 W. 147 feet, more or less, to an iron pin on the rear line; thence along rear line N. 65-22 W. 55 feet, more or less, to iron pin at corner of Lot No. 4; thence along line of Lot No. 4, N. 20-3 E. 147.7 feet, more or less, to an iron pin on the southern side of Pendleton Street; thence along the southern side of Pendleton Street S. 65-41 E. 55 feet to the beginning corner.

Following is a description of the parcel conveyed to the Highway Department:

BEGINNING at a point on the southern side of Pendleton Street, and running thence along Pendleton Street S. 65-41 E. 55 feet to a point; thence running S. 20-30 W. 9.7 feet to a point on the right of way of new highway; thence running along said right of way N. 64-33 W. 15.32 feet to an iron pin; thence continuing along said right of way N. 64-49 W. 39.66 feet to an iron pin; thence running N. 20-30 E. 9.58 feet to the point of beginning. Said area comprises 526 sq. feet.

The property herein conveyed was inherited by the grantors from Grover Phillips Pruitt, who died testate on June 13, 1945, Jennie Maude Pruitt receiving an estate for life with remainder to William Warren Pruitt, see Apt. 497, File 11, Probate Court, Greenville County, S. C. Jennie Maude
