All that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, lying and being situate on the southeastern side of Dogwood Lane within the limits of the City of Greenville, South Carolina, being known and designated as Lot #190 and the Eastern and adjoining 1/2 of Lot #189, according to plat of Cleveland Forest, prepared by Dalton & Neves, May 1940, as revised through October 1949, as recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book "M", page 57, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Southeastern side of Dogwood Lane at joint front corner of Lots #190 and #191; thence S. 25-03 E. 181.7 feet to an iron pin at joint rear corner of Lots #190 and #191; thence S. 72-15 W. 90 feet to a point in the center of the rear line of Lot #189; thence N. 25-15 W. through the center of Lot #189, 172.6 feet to a point on the Southeastern side of Dogwood Lane; thence along said Lane N. 70-54 E. 30 feet to an iron pin at joint front corner of Lots #189 and #190; thence continuing along said Lane N. 64-38 E. 60 feet to an iron pin at joint front corner of Lots #190 and #191, the point of beginning.

The above described property is subject to restrictions recorded in the R.M.C. Office for Greenville County, S. C. in Vol. K at Pages 47 and 90. Said property is further restricted in that no residential building costing less than \$6,000.00 may be built thereon nor nearer than 50 feet to the Street line. Any residential building built on said lot shall face onto Dogwood Lane.

The above described property is identically the same property as that conveyed to the grantors herein by deed of Theron C. Cleveland, Jr., dated April 14, 1965 as recorded in the said R.M.C. Office in Deed Vol. 771 at Page 451.
