the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto

Michael B. Fusonie and Frances S. Fusonie, their heirs and assigns forever:

All that piece, parcel or lot of land in the Town of Mauldin, County of Greenville, State of South Carolina on the southern side of Banner Street and being known and designated as Lot No. 98 on a plat of Glendale Subdivision, plat of which is recorded in the R. M. C. Office for Greenville County in Plat Book "QQ", at Pages 76 and 77 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southern side of Banner Street, joint front corner of Lots Nos. 98 and 99 and running thence with the common line of said lots S. 12-07 W. 175 feet to an iron pin; thence with the rear line of Lot No. 98 N. 77-53 W. 191.6 feet to an iron pin; thence with the common line of Lots Nos. 97 and 98 N. 49-06 E. 152.3 feet to a point; thence continuing with the common line of said lots N. 12-07 E. 54.2 feet to an iron pin on the southern side of Banner Street; thence with the southern side of said Street S. 74-53 E. 27.2 feet to a point; thence continuing with said Street S. 77-53 E. 72.9 feet to an iron pin, the point of beginning.
