All that certain piece, parcel, or lot of land in the County of Greenville, State of South Carolina, on the southerly side of Pine Avenue, being shown and designated as Property of Edward and Ruth B. Fridal, on plat prepared by J. C. Hill, RLS, October 13, 1966, and having, according to said plat, the following metes and bounds, to wit:
