KNOW ALL MEN BY THESE PRESENTS, that I, Dalmus Richmond

in consideration of Sixteen hundred forty nine and 99/100-----Dollars,
and assumption of mortgage hereinbelow setforth,
the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release
unto JACK E. SHAW BUILDERS, INC. its successors and assigns forever:

All that piece, parcel or lot of land in Cleveland Township, Greenville County, State of South Carolina, known and designated as Lots Nos. 40 and 41 of the property of Mrs. Rena Rice Geer, at Blythe Shoals, S. C., according to a plat thereof made by R. E. Dalton in July 1939, and recorded in the R. M. C. Office for Greenville County in Plat Book K at pages 15 and 16 and having the following metes and bounds, to-wit:

BEGINNING at a point on the southern side of the Geer Highway about three (3) miles west of Cleveland, S. C., being joint corner of Lot No. 41 and property heretofore sold to Wade Turner and running thence along the southern side of the Geer Highway, N. 89-15 W. to a point, joint corner of Lots Nos. 40 and 41; thence S. 88-50 W. 100 feet to a point, joint corner (northern) of Lots 39 and 40; thence along the dividing lines of Lots Nos. 39 and 40, approximately S. 9 E. 615 feet to a point, joint southern corner of lots Nos 30 and 40; thence along rear line of Lots nos. 40 and 41, N. 83-15 E. 201.8 feet to a point; thence along the dividing line of Lot No. 41 and property heretofore sold to Wade Turner, N. 9 W. 587 feet to the point of beginning. This being the same property as sold to R. E. Benson by H. C. Hunt, May 4, 1954 and as recorded in the R. M. C. Office for Greenville County in Book 500 and page 465.

ALSO THE FOLLOWING DESCRIBED PROPERTY WHICH ADJOINS THE ABOVE

The following tract of land known as the Eastern portion of Tract No. 3 as shown on plat of property of B. E. Geer and as shown in Plat Book "1", at page 94 and 95, and described as follows:

BEGINNING at a point in the center of Geer Highway and running thence along the center of said highway N. 88-0 W. 450.0 feet to a point in the center of said highway; thence S. 9-0 E. 605 more or less, to an iron pin; thence S. 82-20 East 196 feet to a stone; thence still S. 82-20 E. 184 feet to a stone; thence N. 2-0 W. 636 feet to a point in the center of the Geer Highway, the beginning corner.

THIS being the same property conveyed to me on the 15th day of March 1965 and as recorded in the R. M. C. Office for Greenville County in Book 809 at Page 92.


