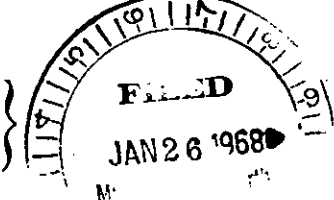

KNOW ALL MEN BY THESE PRESENTS, that I, M. W. Fore,

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto

Charles B. Culbertson and Kate M. Culbertson, their heirs and assigns, forever:

ALL that piece, parcel or lots of land in Greenville County, State of South Carolina, being known and designated as Lots No. 24 and 25, as shown on a Plat of Valencia Estates by W. N. Willis, Engineers, dated November 19, 1960, recorded in the R.M.C. Office for Greenville County in Plat Book MM at Page 179, having according to said Plat the following description, to-wit:

Lots 24 and 25:

BEGINNING on Valencia Drive at an iron pin at joint front corners of Lots 26 and 25 and running thence 160 feet with the line of said Drive to an iron pin at joint front corners of lots 24 and 23; running thence 180 feet with the side line of lot #23 to an iron pin at joint rear corners of lots 23, 24, 33 & 34; running thence 160 feet with the rear lines of lots 33 and 32 to an iron pin at joint rear corners of lots 32, 31, 26 and 25; running thence 180 feet with the side line of lot 26 to the iron pin at joint front corners of lots 25 and 26 on Valencia Drive, the point of beginning.

NO residence to cost less than \$10,000.00 shall be erected on any lot; no residence shall be erected on lots nearer than 35 feet to the front line; no residence shall be built on any lot unless said lot has 70 feet, or more, frontage; no outside toilets permitted and sewage to be disposed of by approved septic tanks; all lots to be used for residential purposes, only.

THIS conveyance is made subject to all rights of way of record.
