KNOW ALL MEN BY THESE PRESENTS, that I, Roy F. King,

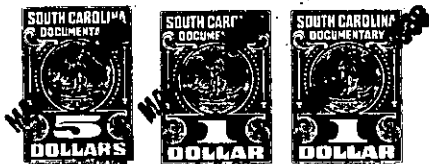
in consideration of Three Thousand Fifty and no/100 (\$3,050.00) Dollars,
