the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Tracy T. Tolliver, his heirs or assigns, forever:

All right, title and interest in and to ALL that certain piece, parcel or lot of land in Greenville County, South Carolina, lying between Colonial Street and Odom Circle and Highlawn Avenue and appearing on the County Tax Map a's Page 147, Block 8, Lot 15A, and according to a recent survey by John C. Smith, has the following metes and bounds, to-wit:

BEGINNING at an iron pin on Colonial Street at the corner of Lot No. 15 and running thence N. 36-31 E. 156.6 feet to an iron pin; thence with the line of Lot No. 14, N. 53-19 E. 169.3 feet to an iron pin on Highlawn Avenue; thence with Highlawn Avenue, S. 79-33 E. 35.7 feet to an iron pin; thence with the bend of Highlawn Avenue into Odom Circle, the chord of which is S. 26-01 E. 42.9 feet to an iron pin; thence with said Odom Circle, S. 07-41 E. 110 feet to an iron pin; thence N. 80-02 W. 146 feet to an iron pin; thence S. 30-37 W. 132.8 feet to an iron pin on Colonial Street; thence with said Colonial Street, N. 79-21 W. 86.7 feet to the point of beginning.
