Allen A. Michaelis and Mary R. Michaelis, their heirs and assigns forever:

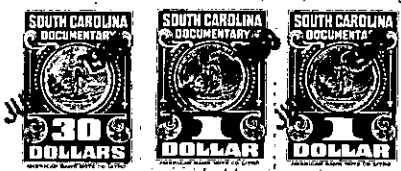
