

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant; bargain, sell and release Potter-Shackelford Construction Company, Inc., its successors and assigns forever:

All that certain piece, parcel or lot of land, with the buildings and improvements thereon, lying and being on the southeasterly side of Lowndes Hill Road, at the intersection of said Road with the northwesterly edge of the right of way for Highway I-385, near the City of Greenville, S. C., and having according to a plat of the property of Potter-Shackelford Construction Company, Inc., made by H. C. Clarkson, Jr., dated June 4, 1968, and recorded in the RMC Office for Greenville County in Plat Book  $\underline{YYY}$ , page  $\underline{5}$ , the following metes and bounds, to-wit:

BEGINNING at a concrete monument on the northwesterly edge of the right of way of Highway I-385, which monument is located a short distance from the southeasterly edge of the right of way of Lowndes Hill Road, and running thence with the northwesterly edge of the right of way of Highway I-385, S 68-46½ E 991.6 feet to an iron pin, corner of Inglesby property; thence turning and running with the line of the Inglesby property N 28-10 W 950 feet to an iron pin located within the right of way of Lowndes Hill Road; thence turning and running on a line within the right of way of Lowndes Hill Road S 51-14 W 259 feet to an iron pin; thence continuing on a line still within said right of way S 44-58 W 402.5 feet to an iron pin; thence turning and running on a line through and beyond the right of way for said Road, S 17-36 E 33.15 feet to the concrete monument, the point of beginning.

This is a portion of the property conveyed to the grantor herein by deed of F. Harold Gillespie, recorded in the RMC Office for Greenville County in Deed Book 832, page 242.

This property is conveyed subject to such right of ways and easements as are shoen on the recorded plat referred to above.
