the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain,, sell and release unto W. H. Alford, his heirs and assigns, forever:

All that piece, parcel or lot of land in O'Neal Township, Greenville County, State of South Carolina, being known and designated as Lot No. 14 of Morrow Estates as shown on plat thereof recorded in the R.M.C. Office for Greenville County in Plat Book 000, Page 157 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southern side of Vera Circle at the joint front corner of Lots 14 and 15 and running thence along the line of Lot 15 S. 15-16 W. 300 feet to an iron pin in the line of Lot 17; thence along the line of Lot 17 N. 66-09 W. 200 feet to an iron pin at the joint corner of Lots 14, 17 and 18; thence along the line of Lot 18 N. 48-39 W. 276.7 feet to an iron pin; thence still with the line of Lot 18 N. 67-43 W. 193.4 feet, more or less, to an iron pin on a branch; thence down the meanders of said branch as the line, the chords being N. 70-38 E. 95.3 feet and N. 3-13 W. 113.3 feet, to an iron pin at the joint corner of Lots 13 and 14; thence along the line of Lot 13 S. 81-00 E. 368 feet, more or less, to an iron pin on the western side of Vera Circle; thence along Vera Circle, and following the curvature thereof, the chords being S. 30-14 E. 99 feet, and S. 75-14 E. 145.9 feet to the beginning corner.
