the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Ernestine Watson Floyd, her heirs and assigns, forever:

All that piece, parcel or lot of land in O'Neal Township, Greenville County, State of South Carolina, being known and designated as Lot No. 12 of Morrow Estates as shown on plat thereof recorded in the R.M.C. Office for Greenville County in Plat Book 000, Page 157, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the western side of Vera Circle at the joint corner of Lots 12 and 13 and running thence along the line of Lot 13 N. 74-57 W. 472.6 feet to an iron pin in a branch; thence down the meanders of said branch as the line, the chords being N. 25-35 E. 99 feet, N. 41-10 E. 76 feet, N. 49-43 E. 149.7 feet, and N. 12-50 E. 118.6 feet, to an iron pin at the joint rear corner of Lots 11 and 12; thence along the line of Lot 11 S. 51-19 E. 431 feet to an iron pin on the northwestern side of Vera Circle; thence along Vera Circle and following the curvature thereof, the chords being S. 41-55 W. 93.1 feet, S. 20-46 W. 100 feet, and S. 17-46 W. 55 feet to the beginning corner.
