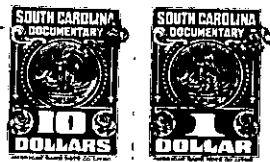
KNOW ALL MEN BY THESE PRESENTS, that Harold L. Bagwell and Frances M. Bagwell
