the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release
unto

Chas. A. Mundy, his heirs and assigns forever:

All that certain piece, parcel, or lot of land situate, lying and being in the State of South Carolina, County of Greenville, near the City of Greenville, being known and designated as Lot No. 156 of a subdivision known as Pine Hill Village as shown on plat prepared by R. K. Campbell, R. L. S., November 30, 1960, and recorded in the R. M. C. Office for Greenville County in Plat Book QQ at Page 168, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the eastern side of West Castle Road, joint front corner of Lots 156 and 157 and running thence along the joint line of said lots, S. 65-19 E. 125.2 feet to an iron pin at the joint rear corner of Lots 148 and 149; thence along therear line of Lot 149, S. 1-09 E. 36.65 feet to an iron pin at the rear corner of Lot 155; thence along the line of that lot, N. 86-13 W. 145.2 feet to an iron pin on the eastern side of West Castle Road; thence along the eastern and southeastern side of West Castle Road, following the curvature thereof in a northeasterly direction, 60.9 feet to an iron pin; thence continuing along the southeastern side of West Castle Road, N. 23-46 E. 34.1 feet to the beginning corner.

This conveyance is subject to restrictions and protective covenants recorded in the R. M. C. Office for Greenville County in Deed Vol. 665, at Page 465 and Deed Vol. 703 at Page 351, and is also subject to utilities and drainage easements which appear of record.
