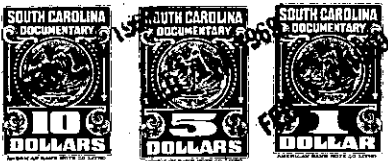
in consideration of Seven Thousand Nine Hundred Eighty-two and No/100 (\$7,982.00) ----- Dollars,
