the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release Robert Lee Moore, his heirs and assigns, all my right, title and interest of, in and to

ALL that piece, parcel or lot of land in Greenville Township, Greenville County, South Carolina, situate, lying and being on the southerly side of the Saluda Dam Road and having, according to a plat of property prepared at the request of R. A. Means, of a survey of W. A. Hester, Surveyor, made March 1, 1929, the following metes and bounds:

BEGINNING at a point in the Leigion Bridge Road (now called Saluda Dam Road) and running thence S. 48 3/4 E. 9.50 chains to a branch; thence up said branch, N. 47 E. 1.40 chains to a point; thence continuing up said branch, N. 68 E. 1.65 chains to a point; thence N. 23 E. 1.99 chains to a sourwood; thence N. 9 3/4 W. 4.20 chains to said Leigion Bridge Road; thence along said Road in a westerly direction, 10.37 chains to the beginning corner and containing 4.4 acres, more or less.

This is the same tract of land which Robert A. Means, Sr. gave his daughter, Alice Moore in the early 1920's. Alice Moore went into possession of said land at the time it was given her and she and those holding under her have been in possession from the early 1920's to the present.

- R. A. Means, Sr. apparently neglected to execute a deed to his daughter, Alice Moore for the within land which he gave to her. This deed is given for the purpose of conveying to Robert Lee Moore any right, title or interest which I might have in said property.
- R. A. Means, Sr. died March 12, 1926, leaving as his only heirs at law and devisees, his wife Alice E. Means and his children, J. E. Means, Hattie Cunningham, Alice Moore and R. A. Means, Jr.
