All my right, title and interest in and to all that certain piece, parcel or lot of land situate, lying and being in Chick Springs Township, Greenville County, South Carolina, being known and designated as Lot No. 93 on plat of Burgiss Hills, prepared by Piedmont Engineering Service and recorded in the R.M.C. Office for Greenville County in Plat Book Y, at Pages 96 and 97, and having the following courses and distances, to wit:

BEGINNING at an iron pin on the south side of Chestnut Avenue at joint front corner of Lots 92 and 93 and running thence along the line of Lot #92, S. 29-16 W. 180 feet to an iron pin; thence S. 60-44 E. 100 feet to an iron pin; thence with the line of Lot No. 94 N. 29-16 E. 180 feet to an iron pin on the south side of Chestnut Avenue; thence with the south side of Chestnut Avenue N. 60-44 W. 100 feet to the beginning corner.

Wade, said appointment being filed in Apartment 1030 at File 24, Probate Court for Greenville County.
