in consideration of Fifteen Hundred (\$1,500.00) Dollars and assumption of mortgage Debt as set out below the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto

Eugene Bolès, His Heirs and Assigns Forever:

All that piece, parcel or lot of land situate, lying and being in the County of Greenville, State of South Carolina, on the eastern side of Kingswood Drive and being known and designated as Lot Number 2 on a plat of Shamrock Acres of record in the Office of the RMC for Greenville County in Plat Book "YY" at Page 43, and having, according to said plat, the following metes and bounds, to wit:
