VAN DEVENTER**, hereafter referred to as Grantor, in consideration of the sum of **FORTY TWO THOUSAND FIVE HUNDRED AND NO/100 (\$42,500.00)** DOLLARS, paid to Grantor by **WILLIE E. HAMES**, hereafter referred to as Grantee, at and before the sealing of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the said Grantee her Heirs and Assigns, forever:

ALL that lot of land with buildings and improvements thereon situate on the West side of Hermitage Road near the City of Greenville, in Greenville County, State of South Carolina, shown as Lot No. 112 of Section II of Lake Forest, according to a plat thereof made by Piedmont Engineering Service, March, 1954, and recorded in the R. M. C. Office for Greenville County, South Carolina, in Plat Book EE, at Page 71, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the West side of Hermitage Road at joint front corner of Lots 111 and 112 and running thence along the line of Lot 111 N. 86-31 W. 180 feet to an iron pin; thence S. 3-29 W. 165 feet to an iron pin on the North side of a 50 foot reserved strip; thence along the North side of the said reserved strip S. 86-31 E. 155 feet to an iron pin; thence with the curve of said strip and Hermitage Road, the chord of which is N. 48-29 E. 35.3 feet to an iron pin on the West side of Hermitage Road; thence with Hermitage Road N. 3-29 E. 140 feet to the beginning corner.

This deed is made subject to all restrictions, zoning ordinances, set back lines, roads or passageways, easements and rights-of-way, if any, affecting the above described property or appearing of record.

It is agreed and understood that possession of the premises hereinabove described is not to be delivered until June 16, 1969.
