That I, T. A. Stephens, hereafter referred to as Grantor, in consideration of the sum of Eighteen Thousand and no/100 - - (\$18,000.00) - - - DOLLARS, paid to Grantor by Drexel, Inc. hereafter referred to as Grantee, at and before the sealing of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the said Grantee, Drexel, Inc., its successors and assigns:

ALL that certain piece, parcel or lot of land known and being the northern portion of the lot designated as the western half of Lot No. 5, according to plat of property of W. D. McBrayer, recorded in the R.M.C. Office for Greenville County in Plat Book "J" at Page 37, and being shown more recently on a plat of the property dated May 1, 1969, recorded in the R.M.C. Office for Greenville County in Plat Book 4B at Page 13, and being further described as follows:

BEGINNING at an iron pin on the right-of-way of the Anderson Road (also known as S. C. Highway No. 81) and running thence with said right-of-way, N. 37-51 E., 100 feet to an iron pin; thence turning and running with the property now or formerly of Black, S. 51-52 E., 393.7 feet to an iron pin at the corner of property now or formerly of Black and property conveyed by deed of even date to W. B. Simmons; thence turning and running with said Simmons line, S. 37-59 W., 99.6 feet to an iron pin at the corner of property now or formerly of Moland-Drysdale Corporation; thence turning and running N. 51-56 W., 393.2 feet to the point of beginning.

ALSO all of my right, title and interest in and to the right-of-way on Anderson Road adjoining the above described property.

This being the same property conveyed to the within named grantor by deed of J. W. Norwood, Trustee, by deed dated October 21, 1939, recorded in the R.M.C. Office for Greenville County in Deed Book 215 at Page 47.

This deed is made subject to any restrictions, rights-of-way, easements or agreements affecting the property that may appear of record, on a recorded plat, or on the premises, or that are known to the grantee.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining;
 TO HAVE AND TO HOLD all and singular the said premises before mentioned unto the Grantee and Grantee's Heirs/Successors and Assigns forever. AND Grantor does hereby bind Grantor and Grantor's Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto Grantee and Grantee's Heirs/Successors and Assigns against Grantor and Grantor's Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
