Coleman Dollars, the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Clyde Coleman, and Mildred B. Coleman,

All that tract of land in the county of Greenville, state of South Carolina, containing 5.3 acres on the southwest side of Hawkins Road, as shown on plat made by Carolina Engineering and Surveying Company May 8, 1969 entitled "Estate of I. W. Coleman" recorded in plat book 4B page 77 of the RMC Office for Greenville County, S. C., and having according to said plat the following metes and bounds, courses and distances, to-wit:

Beginning at an iron pin in the center of Hawkins Road, corner of Hawkins property, thence with the line of said property S. 22-41 W. 419.9 feet to an iron pin; thence S. 3-25 E. 103.1 feet to an iron pin in or near a branch; thence S. 36-52 W. 185.1 feet to an iron pin corner of Montgomery property; thence with the line of said property N. 50-45 W. 435.7 feet to an iron pin; thence N. 31-12 E. 511.5 feet to an iron pin in the center of said Hawkins Road; thence with the center of said Road S. 74-45 E. 248.4 feet to a point; thence continuing with the center of said Road S. 84-34 E. 100 feet to the beginning corner.
