in consideration of Seven Hundred and No/100-----(\$700.00)----- Dollars,

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Ruby Nell Roach, her heirs and assigns forever,

All of that piece, parcel or lot of land located in the County of Greenville, State of South Carolina, consisting of approximately eight-tenths (8/10) of an acre on Old Farris Bridge Road and Blackberry Valley Road, the same being and shown as a portion of the W. A. Taylor Property recorded in Plat Book "X", at Page 138, in the R. M. C. Office for Greenville County, and further shown on a copy of Plat entitled "Survey for Ruby Nell Roach," said plat being recorded in the R. M. C. Office for Greenville County, in Plat Book 4B at Page 89 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at a point in the approximate center of Old Farris Bridge Road and running thence with said Road S82-56W 217.5 feet to a point; thence continuing with said road S89-27W 200 feet to a point; thence N24-15W along Blackberry Valley Road 52 feet to a point; thence N77-0E 415.2 feet; thence S15-57E 116.7 feet to the point of beginning.

Lonie Mae Morgan, Mitchell Douglas Morgan and Linda Ann Morgan conveyed the above-described property to the grantee by separate deed.
