All that certain piece, parcel or lot of land, near the City of Greenville, State of South Carolina, and having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southern side of O'Neill Street, also corne of lot 20 and running thence S. 7-1/4 E. 200 feet to iron pin; thence S. 82-3/4 W. 60 feet to an iron pin; thence N. 7-1/4 W. 200 feet to an iron pin on O'Neill Street; thence with O'Neill Street, N. 82-3/4 E. 60 feet to the beginning corner. Being all of lot 19 of a subdivision known as Morgan Hill recorded in the RMC Office for Greenville County, in Plat Book A, Page 69.

This being the same property conveyed to William O. Miller by E. J. Dunlap on January 9, 1904 and recorded in the RMC Office for Greenville County in Deed Book LLL, at page 232. The said William O.
