in consideration of NINE HUNDRED FORTY SIX & No/100 (\$946.00)-----Dollars,

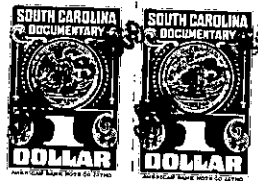
the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto JOHN W. GRUMBLES AND SALLIE B. GRUMBLES, their heirs and assigns, forever:

All that certain piece, parcel or lot of land situate, lying and being in Bates Township, Greenville County, State of South Carolina, containing 4.73 acres, more or less, according to a plat of property of Grace Funk, Julia P. Center, and Elizabeth Funk, dated May 24, 1969, surveyed by Terry T. Dill, Registered Civil Engineer and Land Surveyor, and having according to said plat the following metes and bounds:

BEGINNING at an iron pin at the joint corner of the property herein conveyed and an 8.10 acre tract, said iron pin being located S. 83-06 W. 1121.5 feet from an iron pin located in or near the right-of-way for U.S. Highway No. 25, other property now or formerly of Grantors herein, and property now or formerly of Nichols, running thence S. 83-06 W. 206.5 feet to an iron pin; thence N. 6-39 E. 1072 feet to an iron pin in a ditch; thence S. 32-20 E. 403 feet to a stone, joint corner of tract herein conveyed, a 7.97 acre tract and the 8.10 acre tract herein above referred to, running thence with the line of the 8.10 acre tract S. 10-57 W. 711.8 feet to the point of beginning.

This conveyance is subject to all restrictions, set back lines, roadways, easements and rights of way, of record, if any, affecting the above described property.
