All that certain piece, parcel or lot of land on the West side of Fifth Avenue (Now known as Elmwood Avenue) in Judson Mills #1 Village in the County of Greenville, State of South Carolina, being known and designated as Lot No. 54, as shown on a Plat of Section 1 of Judson Mills Village, made by Dalton and Neves, Engineers, in August 1939, which Plat is recorded in the RMC Office for Greenville County in Plat Book "K" in pages 11 & 12, and having according to said plat the following metes and bounds, to wit:
