KNOW ALL MEN BY THESE PRESENTS, That I, D. E. GALWAY, of the City of Greenville, County of Greenville, State of South Carolina, have constituted, made and appointed, and by these presents do constitute, make and appoint my nephew, Jack E. W. Galway, of Greenville, South Carolina, as my true and lawful attorney, for me and in my behalf in all matters and business, in which I have, or may have, any interest whatsoever, with full power and authority, both as to real and personal estates, to sign, execute, perform and deliver any and all written instruments, which in the judgment of the said attorney should be signed or executed by me. The power and authority herein given is general and unlimited, but it especially includes the right, power and authority to the said attorney in my name and stead to ask, demand, sue for, levy, recover and receive all such sum and sums of money, debts, rents, goods, wares, dues, accounts, and other demands whatsoever, which are or shall be due, owing or payable to me, or detained from me in any manner or ways or means whatsoever. And the special right to deposit in any banking or other financial institution any moneys, by check or otherwise, which I shall be entitled to receive, and to withdraw from any such banking or financial institution any moneys which I may have to my credit in such banking or financial institution. And this power shall especially include the right to handle, care for, control, sell and dispose of any property, real or personal, that I may own, and to purchase for me any property, real or personal, and to execute deeds of conveyance.

Giving and granting unto Jack E. W. Galway, said attorney and his substitute or substitutes, full power and authority to do and perform all and every act as fully to all intents and purposes as I might or could do if personally present, I hereby ratifying and confirming all that Jack E. W. Galway, said attorney, or his substitute or substitutes, shall lawfully do or cause to be done by virtue of these presents.
