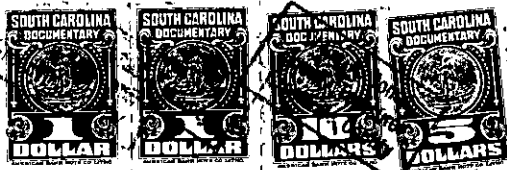
KNOW ALL MEN BY THESE PRESENTS, that Estelle Elrod
