the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release

All that certain piece, parcel or lot of land with the buildings and improvements thereon lying and being on the northerly side of Hillsborough Drive, near the City of Greenville, S. 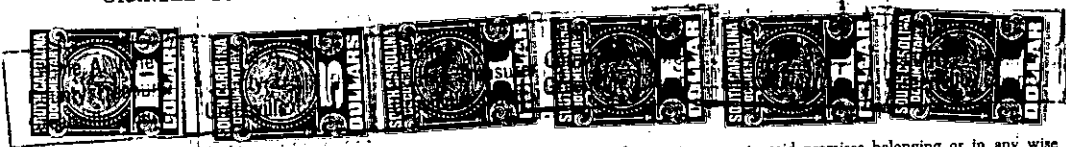

This conveyance is subject to all restrictions, setback lines, roadways, easements and right of ways, if any, affecting the above described property.
