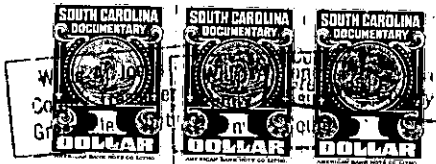
KNOW ALL MEN BY THESE PRESENTS, that I, Francis B. Wilbanks
