 - The property referred to by this agreement is described as follows: Beginning at an iron pin on the southern side of Biscayne Drive, at the joint corner of lots # 15 and 7, and running thence with Biscayne Drive, N. 86-12 E. 86.8 feet to an iron pin; thence continuing with said Drive, M. 79-30 %. 28.2 feet to an iron pin; thence around the curve of said drive, the chord of which is S. 45-M E. 93.2 feet to an iron pin; thence still with said Drive, S. 9-03 W. 77.3 feet to an iron pin, joint corner of lots # 15 and 16; thence with the common line of said lots, N. 82-20 W. 183.2 feet to an iron pin; thence N. 7-10 E. 106.4 feet to the point of beginning. Upon payment of all indebtedness of the undersigned to Bank this agreement shall be and become void and of no effect, and until then it shall apply to and bind the undersigned, their heirs, legatees, devisees, administrators, executors, successors and assigns, and inure to the benefit of Bank and its successors and assigns. The affidavit of any officer or department manager of Bank showing any part of said indebtedness to remain unpaid shall be and constitute conclusive evidence of the validity, effectiveness and continuing force of this agreement and any person may and is hereby authorized to rely thereon.
