the receipt of which is hereby acknowledged, have granted, bargained, sold, and released and by these presents do grant, bargain, sell and release unto---Elise J. Mullikin, her heirs and assigns forever:

ALL that piece, parcel, or lot of land, situate, lying and being near the Town of Piedmont, in the County of Greenville, State of South Carolina, being known as Lot No. 4, on Plat of Property of Estate of V. L. Johnson, which plat is recorded in the RMC Office for Greenville County in Plat Book 4F, Page 28, and having, according to said plat, the following metes and bounds, to-wit:
