ALL that piece, parcel or lot of land, situate, lying and being near the Town of Piedmont, in the County of Greenville, State of South Carolina, being known as Lot No. 9, on Plat of Property of Estate of V. BEGINNING at an iron pin on the northerly side of a County Road, said iron pin being 1,084 feet from the intersection of Pelzer Road and the said County Road, joint front corner Lots 8 and 9; and running thence along said County Road, S. 75-08 W. 80 feet to an iron pin; thence S. 81-05 W. 40 feet to an iron pin, joint front corner Lots 9 and 10; thence N. 7-45 W. 444.3 feet to an iron pin; thence N. 83-08 E. 80 feet to an iron pin, joint rear corner Lots 8 and 9; thence S. 12-57 E. 434.2 feet to an iron pin on said County Road, the point of beginning.
