KNOW ALL MEN BY THESE PRESENTS, that We, E. P. Gravitt, Sr., and E. P. Gravitt, Jr.

in consideration of Six Hundred and No/100ths (\$600.00) Dollars, the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Edith B. Littleton, her heirs and assigns, forever;

ALL of that lot of land in the County of Greenville, State of South Carolina, in Chick Springs Township, on the southeastern side of Kimberly Drive, a short distance south of the intersection of State Park Road, Highway 253, as shown on plat of E. P. Gravitt made by Carolina Engineering and Surveying Co., dated November 19, 1969, and recorded in the R. M. C. Office for Greenville County in Plat Book CCCC, page 181, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the eastern side of Kimberly Drive on the line between the property of the Grantors and the Grantee, and being the old original dividing line between the Holcombe tract and the Turner tract, said iron pin being situate 276 feet south of the intersection of Kimberly Drive and S. C. Highway 253, referred to as State Park Road, and running thence along the property of the Grantee as shown on plat of Edith B. Littleton made by Terry T. Dill, dated October 17, 1959, and September 3, 1955, S 3-05 W 273.5 feet to an iron pin at the corner of property this day being conveyed to Wallace B. James, and running thence along said property N 85-56 W 169.5 feet to an iron pin on the eastern side of Kimberly Drive; thence along the eastern side of Kimberly Drive the following courses and distances, to-wit: N 35-10 E 83.9 feet to an iron pin; thence N 43-20 E 127 feet to an iron pin; thence N 35-25 E 74.2 feet to an iron pin; thence N 7-37 E 39.5 feet to the point of beginning and being a portion of the property conveyed to us in Deed Book 305, page 12, and Deed Book 738, page 524. This property is conveyed subject to all rights-of-way and restrictions of record.

Reference may be had to Plat Book CCC, page 37, and is shown on Sheet 498.1, Block 1, as part of Lot 1 on the County Block Book System.
