the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Terry A. Wallace, his heirs and assigns,

All that lot of land in Greenville County, state of South Carolina, being known and designated as Lot No. 163 as shown on plat of South Forest Estates, recorded in plat book GG page 181 of the RMC Office for Greenville County, S. C. and having according to said plat the following metes and bounds, to-wit:

Beginning at an iron pin on the north side of West Belvedere Road at the joint front corner of Lots 163 and 164 and runs thence along the line of Lot 164 N. 5-20 W. 130.1 feet to an iron pin; thence N. 75-43 E. 86.9 feet to an iron pin on the west side of Pinefield Drive; thence along Pinefield Drive S. 5-20 E. 108.5 feet to an iron pin; thence with the curve of Pinefield Drive and West Belvedere Road (the chord being S. 35-10 W. 32.4 feet) to an iron pin on the north side of West Belvedere Road; thence along West Belvedere Road S. 75-37 W. 65.6 feet to the beginning corner.
