the receipt of which is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and  
release unto C. S. Willingham, his heirs and assigns:

ALL that piece, parcel or lot of land situate, lying and being in the  
County of Greenville, State of South Carolina, and located on the  
westerly side of Cunningham Road and being shown and designated as  
Lot No. 62 on a plat of Drexel Terrace, dated April 1, 1961, and prepared  
by Piedmont Engineering Service, recorded in the Office of the RMC for  
Greenville County in Plat Book QQ at Page 177, and being more particularly  
described with reference to said plat as follows:

BEGINNING at a point on the westerly side of Cunningham Road at the joint  
front corner of Lots Nos. 62 and 61; thence along Cunningham Road, S. 15-40 E.  
100 feet to a point, joint front corner of Lots Nos. 63 and 62; thence  
turning and running S. 79-08 W. 185.3 feet to a point in rear line  
of Lot No. 40; thence turning and running N. 14-05 W. 75 feet to a point;  
thence along the rear line of Lot No. 41, 30 feet to a point; thence  
turning and running N. 80-45 E. 179.8 feet to the point of beginning  
on Cunningham Road.

Said lot is subject to protective covenants for Drexel Terrace recorded  
on April 7, 1961 in the Office of the RMC for Greenville County in Deed  
Book 671 at Page 355 and to building setback line as shown on said plat.

This is a portion of the property conveyed to the Grantor herein by deed  
of W. B. Simmons, recorded on April 3, 1961 in the Office of the RMC  
for Greenville County in Deed Book 671 at Page 155.
