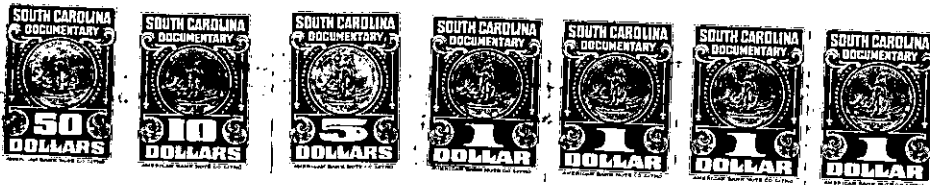
in consideration of Thirty-four Thousand three Hundred (\$34,300.00) Dollars,
