in consideration of THREE THOUSAND FIVE HUNDRED AND NO/100 (\$3,500.00)----- Dollars,

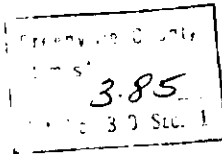
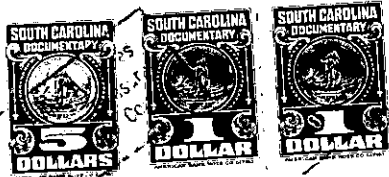

ALL that piece, parcel or lot of land situate, lying and being in the City and County of Greenville, State of South Carolina, on the southeastern side of Queen Street and being known and designated as Lot No. 100 on plat of property of McBee Estates recorded in the RMC Office for Greenville County in Plat Book "K", at page 117, and having, according to said plat, the following metes and bounds, to wit:

BEGINNING at an iron pin on the southeastern side of Queen Street at the joint front corner of Lots Nos. 100 and 101, which point is 102 feet in a northeasterly direction from the northeastern corner of the intersection of Queen Street and Lindberg Avenue and running thence along the joint line of Lots Nos. 100 and 101, S. 60-47 E. 137.8 feet to an iron pin; thence N. 26-15 E. 44 feet to an iron pin; thence N. 58-43 W. 119.6 feet to an iron pin on the southeastern side of Queen Street; thence along said Street, S. 17-37 W. 51 feet to the point of beginning.
