KNOW ALL MEN BY THESE PRESENTS, that William W. Campbell and Audrienne H. Campbell

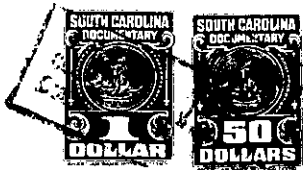
in consideration of TWENTY-FIVE THOUSAND FIVE HUNDRED and NO/100---(\$25,500.00)----- Dollars,

ALL that certain piece, parcel or lot of land in Greenville County, State of South Carolina, in the Town of Mauldin, on the northerly side of Elm Drive and being known and designated as Lot 50-A and a portion of Lot 50 on plat of EASTDALE DEVELOPMENT recorded in Plat Book YY at Pages 118 and 119 and a more recent survey prepared by Campbell and Clarkson, and having, according to said survey, the following metes and bounds, to-wit:

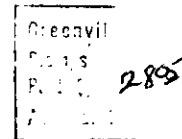
