PARCEL 2: All that piece, parcel or lot of land situate, lying and being on the southeast side of River Drive, at River Falls, in Cleveland Township, Greenville County, South Carolina, being shown as Lot 11 on plat of Cool River Heights, made by J. C. Hill, Surveyor, September 2, 1947, recorded in Plat Book S at page 5 and described as follows:

BEGINNING at an iron pin in the center of River Drive, joint front corner of Lots 10 and 11 and running thence with the line of Lot No. 10, S 52-45 E 225 feet to an iron pin in the center of Gap Creek; thence up Gap Creek in a northeasterly direction 110 feet, more or less, to an iron pin in the center of Gap Creek, at rear corner of Lot No. 12; thence with the line of Lot 12, N 52-45 W 257 feet to an iron pin in the center of River Drive; thence with the line of center of River Drive S 34 W 97 feet to the beginning corner.

Parcel 1 having been conveyed to James J. Pennoyer by deed recorded in Deed Book 188 at page 58 and Parcel 2 having been conveyed to Erna B. Pennoyer by deed recorded in Deed Book 528 at page 420 in the RMC office for Greenville County.

It is understood that the grantors reserve unto themselves a life estate in the property, that is, the right to occupy the property for and during their natural lives and the survivors of them.
