BEGINNING at an iron pin on the South Side of Chisolm Trail joint front corner of Lots 10 and 11 and running along Chisolm Trail N. 59-11 E. 70 feet to an iron pin; thence continuing with Chisolm Trail N. 58-57 E. 70.8 feet to an iron pin, joint front corner of Lots 9 and 10; thence along the line of Lot 9 S. 48-17 E. 134 feet to an iron pin, joint rear corner of Lots 9 and 10; thence S. 61-28 W. 157 feet to a point in branch; thence with a traverse line with the branch being the line N. 42-05 W. 123.7 feet to an iron pin on Chisolm Trail, joint front corner of Lots 10 and 11, the beginning corner.
