The property referred to by this agreement is described as follows: All that lot of land with the buildings and improvements thereon situate on the northeast side of Bridgeport Drive, near the City of Greenville, in Greenville County, S. C. being shown as Lot #79 on plat of Section 2 of Wellington Green, recorded in the RMC Office for Greenville County, South Carolina, in Plat Book YY, page 117, and having according to said plat, the following metes and bounds, to wit: Beginning at an iron pin on the northeast side of Bridgeport Drive at the joint front corner of Lots 78 & 79 and runs thence with the line of Lot 78, N. 32-15E, 170 feet to an iron pin, thence N 57-45 W., 100 feet to an iron pin, thence with the line of Bridgeport Drive, thence along Bridgeport Drive, S. 57-45 E, 100 feet to the beginning corner.

That if default be made in the performance of any of the terms hereof, or if default be made in any payment of principal or interest, on any notes hereof or hereafter signed by the undersigned, the undersigned agrees and does hereby assign the rents and profits arising or to arise from said premises to the Bank and agrees that any judge of jurisdiction may, at chambers or otherwise, appoint a receiver of the described premises, with full authority to take possession thereof and collect the rents and profits and hold the same subject to the further order of said court.

Upon payment of all indebtedness of the undersigned to Bank this agreement shall be and become void and of no effect, and until then it shall apply to and bind the undersigned, their heirs, legatees, devisees, administrators, executors, successors and assigns, and inure to the benefit of Bank and its successors and assigns. The affidavit of any officer or department manager of Bank showing any part of said indebtedness to female unpaid shall be and constitute conclusive evidence of the validity, effectiveness and continuing force of this agreement and any person may and is hereby authorized to rely thereon.
