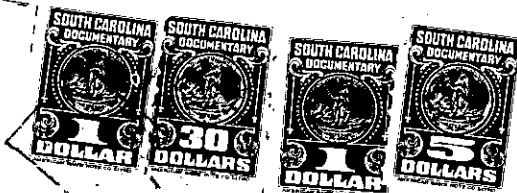
in consideration of Eighteen Thousand One Hundred and no/100ths (\$18,100.00)-----Dollars,

All that lot of land in the county of Greenville, state of South Carolina, being a portion of Lot No. 14 on plat of Fore Estates subdivision recorded in the RMC Office for Greenville County in Plat Book BB at page 61, and being designated as Lot No. 14 B on survey made by Carolina Engineering & Surveying Company, dated February 23, 1971 and having according to said plat the following metes and bounds, courses and distances, to-wit:
