All that certain piece, parcel or lot of land, with all improvements thereon, situate, lying and being in the State of South Carolina, County of Greenville, Chick Springs Township, on Edwards Road, being known and designated as Lots 12, 13 and part of 11, Block B of Mayfair Estates Subdivision as shown on a plat thereof being recorded in the R. M. C. Office for Greenville County in Plat Book S at Pages 72 and 73 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on Edwards Road, joint front corner of Lots 13 and 14 and running thence with the joint line of said lots, N. 60-48 W. 150 feet to an iron pin; thence N. 29-12 E. 125 feet to a point in the center of the rear line of Lot 11; thence with a new line through the center of Lot 11, S. 60-48 E. 150 feet to a point in the center of Lot 11 on Edwards Road, thence S. 29-12 W. 125 feet along Edwards Road to the beginning corner; being the same property conveyed to J. P. Medlock by Frank W. Loftis, Jr. by deed dated May 12, 1971 and recorded in Deed Vol. 915 at Page 161.
