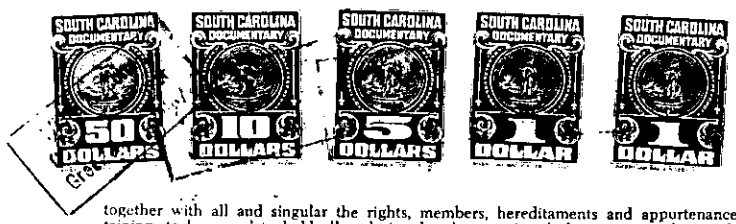
KNOW ALL MEN BY THESE PRESENTS, that --Ellis L. Darby and A. James Nelson-----
