"ALL that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, in School District 8-AA, being a portion of Lot 120 of Block A of the subdivision known as City View as shown on a plat recorded in Plat Book A, at page 461 and having the following metes and bounds: BEGINNING at a stake at the joint corner of Lots Nos. 120 and 121 on the western side of a street now known as Hollis Street and thence running with the line of Lot No. 121 North 89½ West 125 feet to a stake; thence South 0-30 West 50 feet to a stake in the line of Lot 119; thence with the line of that lot South 89½ East 125 feet to a stake on Hollis Street; thence with the line of said street North 0-30 East 50 feet to the BEGINNING corner.
