That I, H. H. Cox, - - -

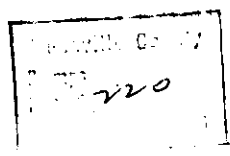
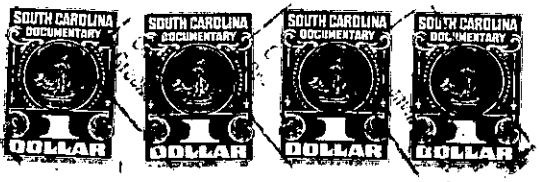
