Know all men by these presents: William Harold Neal and Jeanie Mae Neal have agreed to sell to Alden Watts Jr. and Brenda Joyce Watts a certain lot or tract of land in the County of Greenville, State of South Carolina, on the southwest side of Batesville Road at the end of an unnamed County Road and containing five acres, more or less, and same being \_\_\_\_\_ feet on front and going to a point on the rear with right side going \_\_\_\_\_ feet in depth and left side \_\_\_\_\_ in depth, and execute and deliver a good and sufficient warranty deed therefor on condition that buyer shall pay the sum of Ten Thousand, Five Hundred and No/100 Dollars in the following manner: \$250.00 down, receipt of which is hereby acknowledged, and \$50.00 each month hereafter beginning September 1, 1969, until the full purchase price is paid, with interest on same from date at 6 per cent, per annum until paid, to be computed and paid annually, and if unpaid bear interest until paid at same rate as principal, and in case said sum, or any part thereof be collected by an attorney, or through local proceedings of any kind, them in addition the sum of \_\_\_\_\_ dollars for attorney's fees, as is shown by note of even date herewith. The purchaser agrees to pay all taxes while this contract is in force.

It is agreed that time is of the essence of this contract, and if the said payments are not made when due Buyer shall be discharged in law and equity from all liability to make said deed, and may treat said Alden Watts Jr. and Brenda Joyce Watts as tenant, holding over after termination, or contrary to the terms of this agreement shall be entitled to claim and recover, or retain if already paid the sum of all monies paid dollars per year for rent, or by way of liquidated damages, or may enforce payment of said note.
