the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Maxie Henry Burns and Josie D. Burns, their heirs and assigns forever:

ALL that piece, parcel or lot of land located, situate and lying in the County of Greenville, State of South Carolina, and containing about 1.35 acres according to a Plat of property of Malinda E. Burns prepared by Jones Engineering Service on March 18, 1971, and being designated Max H. Burns' property, and according to said Plat, having the following metes and bounds, to-wit:

BEGINNING at an iron pin located East of New Buncombe Road and being the South East corner of property now owned by Maxie H. Burns; thence with the rear property line of Maxie H.
