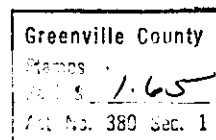
All that certain piece, parcel or lot of land in the State of South Carolina, County of Greenville, lying on the northern side of Sevier Street in Chick Springs Township, and being known and designated as Lot No. 6 on plat of Piedmont Park prepared by Dalton and Neves, dated May 1940, recorded in plat book X page 175 and having according to said plat the following metes and bounds, to-wit:

Beginning at a point on the northern side of Sevier Street, joint front corner of Lots 5 and 6 (iron pin 11 feet from the northern side of Sevier Street); thence N. 12-46 E. 185.1 feet to Elm Drive (iron pin 3 feet from the southern side of said Drive); thence N. 82-18 W. 100 feet along the southern side of Elm Drive to a pin, the joint corner of Lots 6 and 7; thence S. 12-44 W. 186.3 feet to the edge of Sevier Street (iron pin 7 feet north of Sevier Street); thence with Sevier Street S. 83-00 E. 100 feet to point of beginning.

This is the same property conveyed to Grantor by Claude H. Dowd by deed dated July 15, 1971 and recorded in the RMC Office for Greenville County in deed vol. 920 at page 341, and is conveyed subject to any recorded restrictions easements or rights of way or those shown on the premises.

As part of the consideration for this conveyance the Grantee assumes and agrees to pay that certain mortgage held by Southern Bank & Trust Co. in the amount of \$9,000.00 recorded July 15, 1971 in the RMC Office for Greenville County in vol. 1198 at page 615, on which there is a balance due of \$9,000.00.
