KNOW ALL MEN BY THESE PRESENTS, that C. S. Mattox and Wilson M. Dillard -----

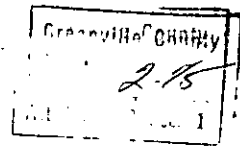
in consideration of Two Thousand Three Hundred and No/100 (\$2,300.00) -----Dollars,
